

## STCW95+10 BASIC SAFETY TRAINING COURSE – 6-day



STCW = Standards of Training Certification and Watch Keeping for Seafarers.

The International Standard for the Training Certification and Watch Keeping for Seafarers 1995, amended by Manila Amendments 2010, is mandated by the International Maritime Organization (IMO), and has the force of law in 154 signatory countries. Although experience at sea remains an important part of a seafarer's overall career development, it is no longer enough to "serve your time."

**All crew members are required to complete the STCW 95+10 training modules, regardless of their position onboard.**

All yacht crew are required to have the International STCW95 as amended by Manila Amendments 2010 certificate (STCW95+10) or the Australian Shipboard Safety Skill Set. It must also be refreshed every 5 years.

The 1995 STCW Convention, amended by the Manila Amendments 2010 establishes a baseline standard for the training and education of seafarers throughout the world. STCW 95+10 stipulates the required competencies associated with different tasks, the knowledge and understanding required to perform them, methods for demonstrating competence and criteria for evaluating it. The Convention embodies provision for "hands-on" training and the development of basic skills through use of simulators, laboratory training equipment and other practical training aids.

The convention was amended/expanded to include Maritime Security Awareness. Crew members who do not have the additional Security endorsements must take an update course to maintain the validity of their earlier training.

**We offer an MCA-approved STCW Basic Safety course over 6 days.** The competency units covered in the STCW 95+10 training course are:

- Sea Survival - (Table A – VI/1-1), MARF001, MARF005
- Marine Fire Fighting and Fire Prevention – (Table A – VI/1-2), MARF002
- First Aid - (Table A – VI/1-3), HLTAID003
- Personal Safety and Social Responsibility - (Table A – VI/1-4), MARF004
- Maritime Security Awareness – (Reg V1-6 and Part A of Section A – VI/6 Paragraph 4)

**HOW LONG IS THE COURSE?** Six days, from 8:00 AM Monday to 5:00 PM Saturday

**WHERE DO THE COURSES TAKE PLACE?** The theory and practical classroom sessions (Monday-Thursday) are held at a training facility in Newport, about 45mins North of Sydney's CBD. The Firefighting Practical (Friday) is held at TAFE NSW Nirimba College Fire Grounds in Quakers Hills, and the Sea Survival Practical (Saturday) is held at the QANTAS Jet Base Pool at Sydney Airport, Mascot.

These courses are run by our training partners who certify under the "International Yacht Training" (IYT) banner. Accommodation nearby is recommended for those who need to commute to the location in Newport.

Your certificates will carry the IYT logo which has recognition with 25 governments across the globe. The certification is approved by the Maritime Coastguard Agency (MCA).

You will graduate with internationally recognised STCW Basic Safety Training certificates.

This course provides you with dual certification, which means your training qualifies you to obtain the Australian 'Statement of Attainment.' This Statement of Attainment meets the requirements for the Shipboard Safety Skill Set, which is recognized by the Australian Maritime Safety Authority (AMSA). You will also achieve a Statement of Attainment for the first aid unit of competency.

**HOW MUCH DOES THE COURSE COST?** AUD \$2,250.

**PACKAGE DISCOUNTS** apply when you book this course along with a vocational course: Steward/ess or Deckhand. STCW95 certification is a requirement for a crew position on a Superyacht but does not, by itself, qualify you for a crew position. You need additional training, certification and experience if you want a Captain to offer you a job. If you lack these skills and certification, we recommend you sign up for the Superyacht Deckhand or Superyacht Interior Crew course at the same time to be eligible for a special package price.

#### **AGREEMENT FOR GENERAL BOOKINGS**

When a confirmed booking is made and accepted by SCI. (hereafter referred to as the 'Company' a binding contract shall be deemed to subsist between both parties. No liability shall accrue to either the Company or student if either is prevented from fulfilling any of their contractual obligations by any incidence of force majeure including acts of God, strikes, or any other event which can reasonably be beyond the control of either party. In the event of any dispute arising out of the terms of this contract, it shall be referred to a mutually acceptable arbiter whose decision shall be binding to both parties. It is understood that the student will indemnify the Company or Training Partner company for any non-insurable claims that may be made against it for damage or loss caused by the student or by members of their party whether wilful or through negligence.

#### **BOOKING CANCELLATION OR RESCHEDULING**

CANCELLATION OR RESCHEDULING a booking inside 30 days must be made verbally AND in writing by the person who completed the booking and be sent to the Company at their address and is deemed to take effect on receipt.

Cancellations or rescheduling made between 30 and 15 days will incur a loss of deposit. Balance of payment is to be no later than 15 days prior to commencement of the course.

There will be no REFUNDS given for cancellations made inside 15 days. If a student leaves the yacht and/or abandons a course or mile-builder trip before the scheduled termination date and time for whatever reason NO REFUNDS will be given.

When the deposit to secure a place in a course has been made and if the student then cancels or reschedules outside 30 days, an administration/service fee of \$150 will BE CHARGED.

Any course material that has been issued to the student, MUST be returned to the Company or Training Partner company before the remainder of the deposit is refunded.

**INSURANCE:** It is advisable to be covered by an insurance policy for the adventure sailing trips to safeguard yourself in the case of cancellation. A copy of the policy is to be forwarded to the Company.

#### **WEATHER CONDITIONS**

Whilst every effort will be made by the Instructor to give the students maximum time on the sea, weather conditions may be such that, in the opinion of the Instructor, the yacht or crew may be in danger and in such circumstances the vessel will remain in a place of safety. If the weather conditions are such that a prevention of the start or curtailment of a course or sailing trip occurs then no refunds will be given but alternative dates will be offered.

#### **TRANSFER/CANCELLATION**

The Company or Training Partner company reserves the right at its discretion to transfer the course or sailing trip from one yacht to another and this action will in no way waive the terms and conditions stated herein. In the event of the Company or Training Partner company having to cancel a course or sailing trip, without offering any acceptable alternative then the student shall be entitled to a full refund of monies paid and no further liability shall be incurred by the Company or Training Partner company.

**MEDICAL:** The student agrees to advise the Company or Training Partner company in writing of any medical disability or illness which may adversely affect the ability to participate in the course or sailing trip that they have chosen. It shall be at the discretion of the Company or Training Partner company to refuse to accept a booking of a student where there is an unacceptable risk to the party and the Company or Training Partner company in doing so.
